Organic waste India (pvt ltd)	Company should give a presentation to Worshipful Mayor, Hon'ble Ministers for Health and Family Welfare and to the Law and Parliamentary Affair Minister on 27/10/2012 and to set up the Plant within 4 months to accept minimum 400 MT waste every day. Commissioner BBMP should depute team of Senior Officer to inspect the newly set up Plant at Sholapur. Advance Payment to Eco sorb for spraying E.M Solution at Mandur	Commissioner BBMP to take action
